This license is a pouring license and authorizes the holder to sell beer by the drink for consumption by the purchaser at the premises of the license holder. (Requires fifty percent (50%) of gross revenues from sales of food or services.)

_____ **Class B2— General – wine**

This license is a pouring license and authorizes the holder to sell wine by the drink for consumption by the purchaser at the premises of the license holder. (Requires fifty percent (50%) of gross revenues from sales of food or services.)

_____ **Class B3—Bars – Available beginning 02/01/2022**

This license is a pouring license and authorizes the holder to sell beer and wine by the drink for consumption by the purchaser at the premises of the license holder. (Requires an inventory of at least \$5,000.)

_____ **Class B—Brown bagging**

This license allows patrons to bring their own beer or wine to the premises of the license holder for consumption.

Class C—Retail liquor by the drink

_____ **Class C1— General**

This license is a pouring license and authorizes the holder to sell liquor drinks for consumption by the purchaser at the premises of the license holder or off-premises provided it is sealed. (Requires fifty percent (50%) of gross revenues from sales of food or services for consumption.)
